

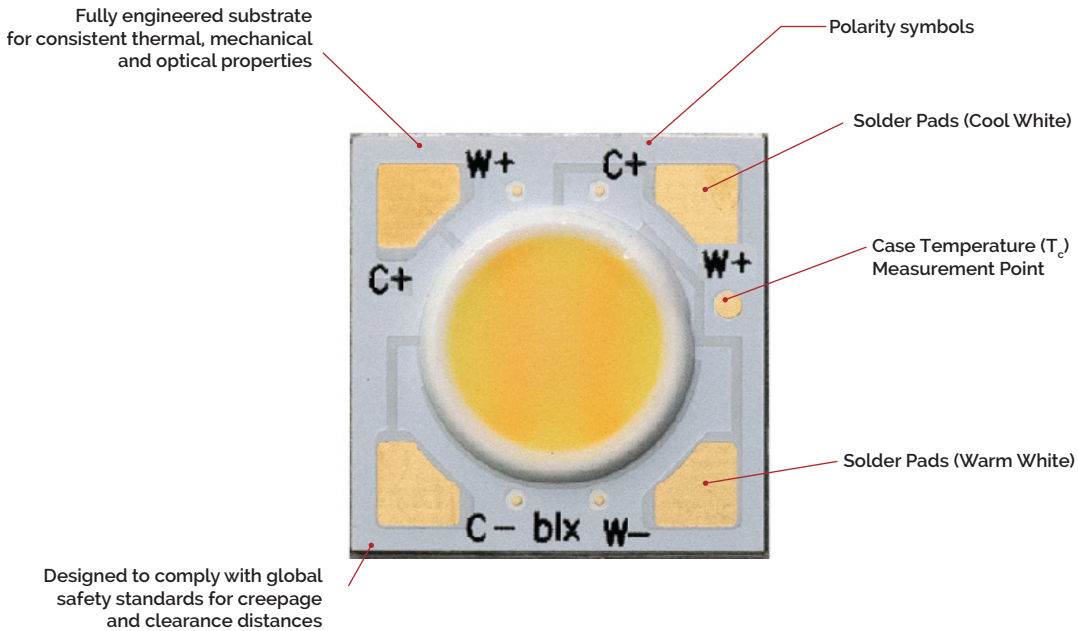

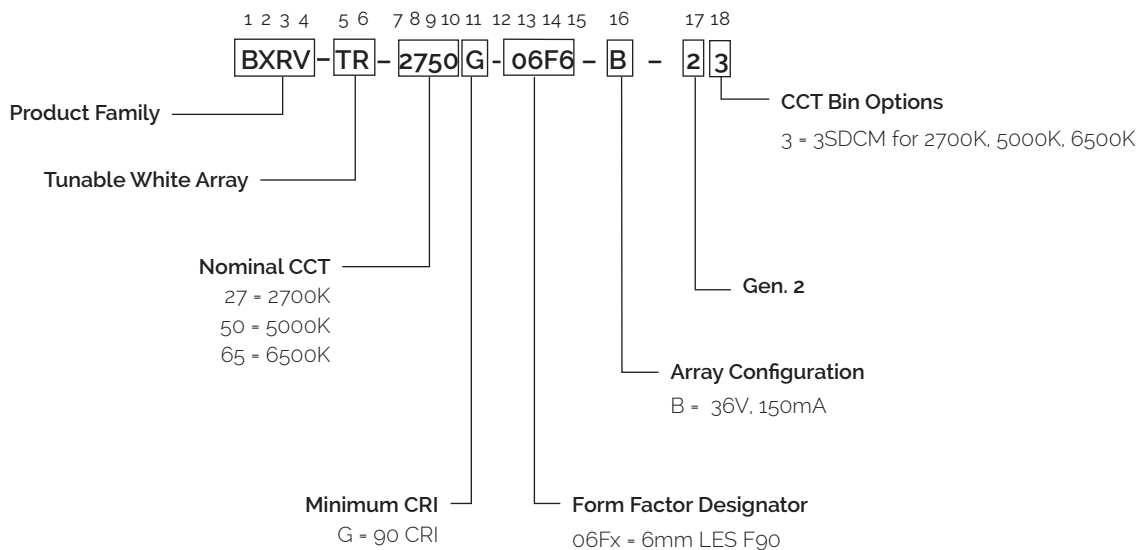

2. For CRI 90 products, the minimum CRI value is 90 and the minimum R_g value is 50 @ 50°C. Bridgelux maintains a ±3 tolerance on all R_g values.
3. Products tested under pulsed condition (10ms pulse width) at nominal drive current where T_j (junction temperature) = T_c (case temperature) = 25°C.

European Product Registry for Energy Labeling

The European Product Registry for Energy Labeling (EPREL) is defined in the EU Regulation 2017/1369 to provide information about a product's energy efficiency to consumers. Together with Energy Labeling Regulation ELR (EU) 2019/2015, which was amended by regulation (EU) 2021/340 for energy labelling of light sources, manufacturers are required to declare an energy class based on key technical specifications from each of their product and register it in an open data base managed by EPREL. It is now a legal requirement for a vendor of light sources to upload information about their products into the EPREL database before placing these products on the market in the EU.

Table 2 provides a list of part numbers that are in compliance with EPREL regulations and are currently listed in the EPREL database.

- Bridgelux maintains a tester tolerance of ± 0.10V on forward voltage measurements.
- Typical temperature coefficient of forward voltage tolerance is ± 0.1mV for nominal current.
- Thermal resistance value was calculated using total electrical input power; optical power was not subtracted from input power. The thermal interface material used during testing is not included in the thermal resistance value.
- V_f min hot and max cold driver selection voltages are provided as reference only and are not guaranteed by test. These values are provided to aid in driver design and selection over the operating range of the product.
- This product has been designed and manufactured per IEC 62031:2018. This product has passed dielectric withstand voltage testing at 500 V. Example for BXRV-TR-27xxG-06Fx-B-2x: If 200mA is applied to one channel, no current may be applied to the other channel. If 150mA is applied to one channel, then a maximum of 50mA can be applied to the other channel.
5. Bridgelux recommends a maximum duty cycle of 10% and pulse width of 20ms when operating LED arrays at the maximum peak pulsed current specified. Maximum peak pulsed currents indicate values where the LED array can be driven without catastrophic failures.

Figure 1: Forward Voltage vs. Forward Current, $T_c=25^\circ\text{C}$

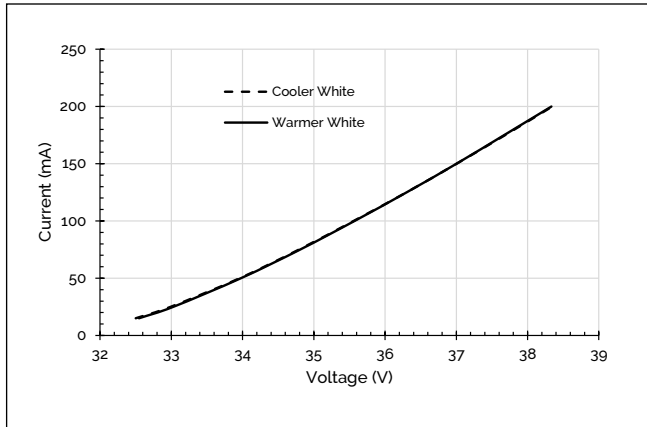


Figure 2: Relative Flux vs. Drive Current, $T_c=25^\circ\text{C}$

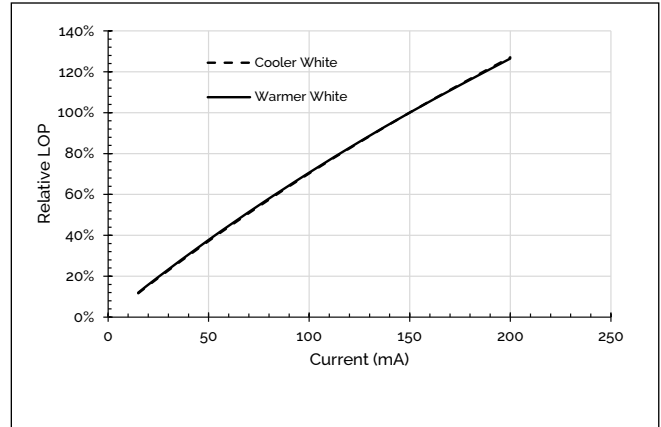


Figure 3: Relative Voltage vs. Case Temperature

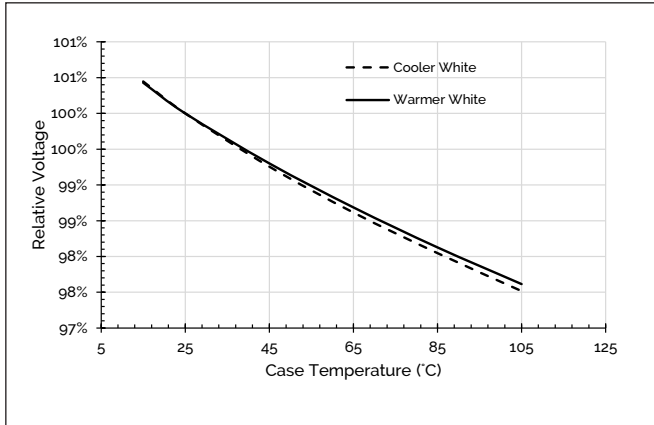


Figure 4: Relative Flux vs. Case Temperature

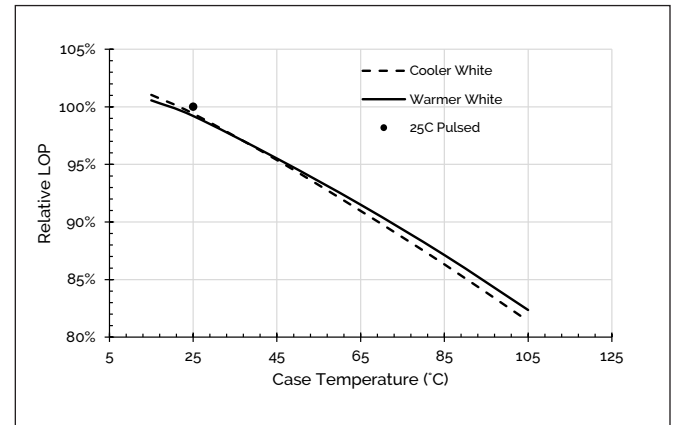


Figure 5: CCT vs. Relative Current, $T_c=85^\circ\text{C}$

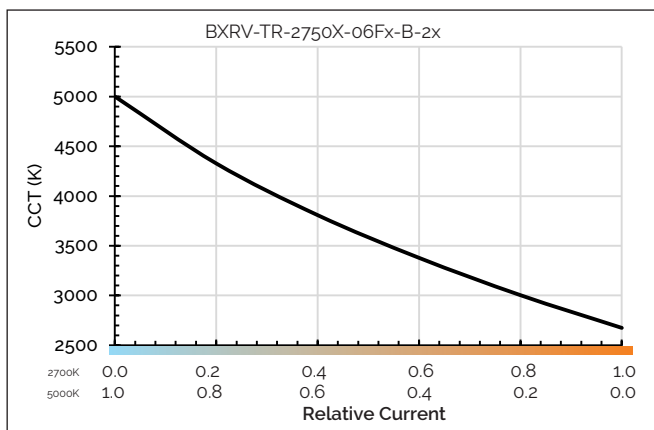
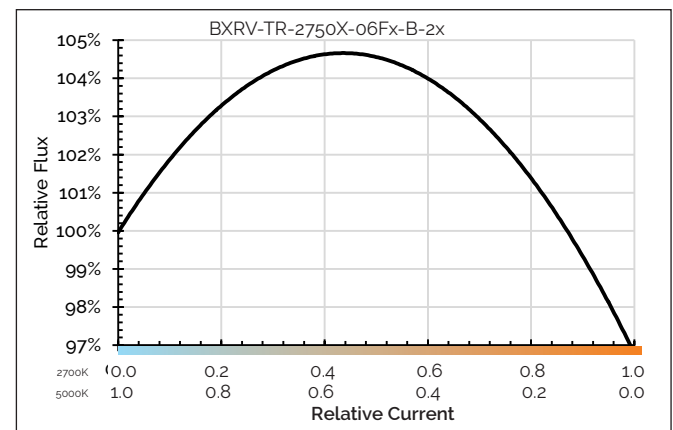


Figure 6: Relative Flux vs. Relative Current

Figure 7: CCT vs. Relative Current, $T_c=85^\circ\text{C}$

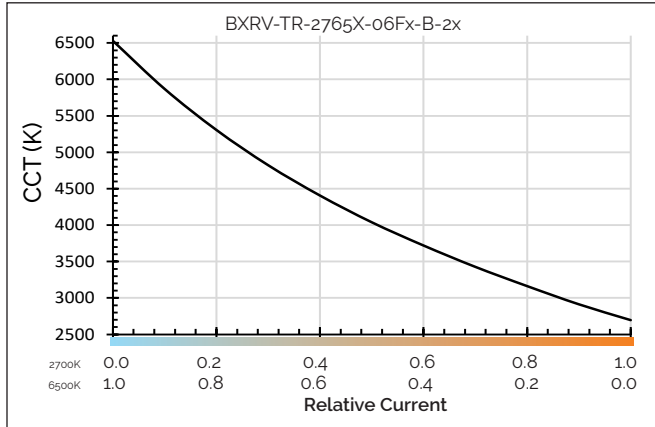


Figure 8: Relative Flux vs. Relative Current

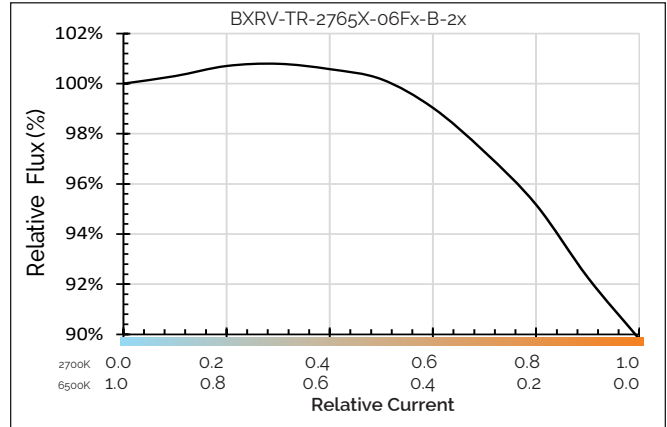


Figure 9: CCT Tuning Range, $T_c=85^\circ\text{C}$

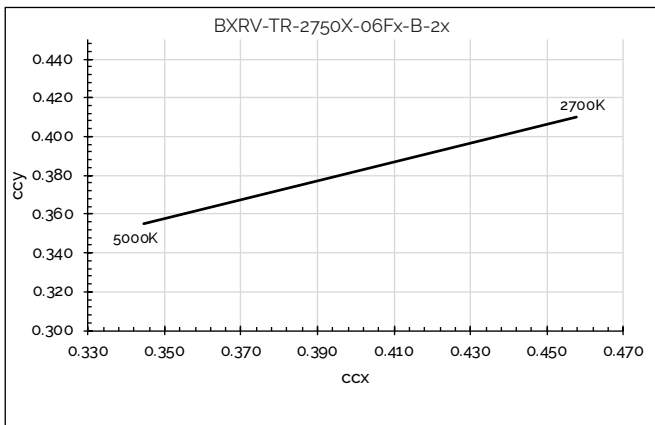
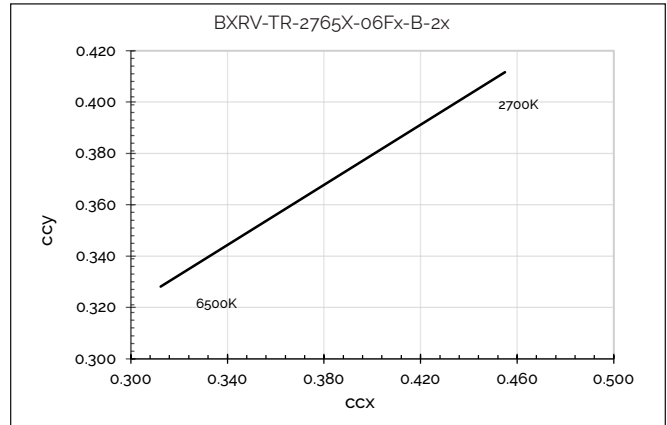
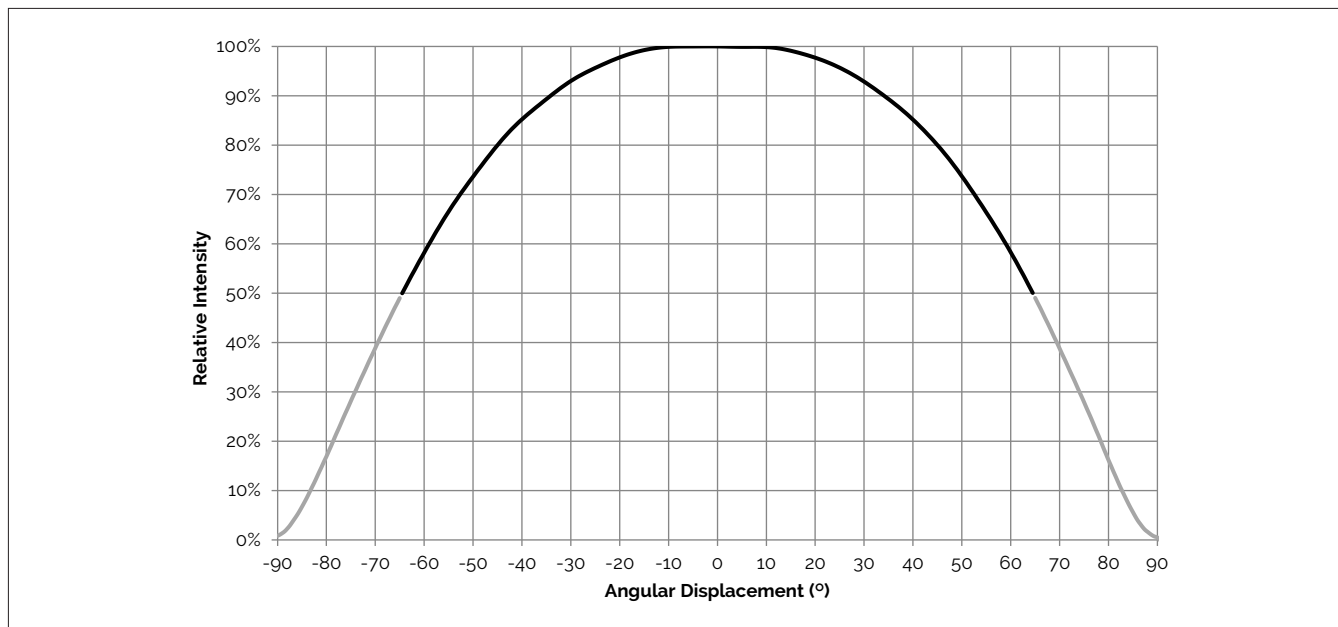


Figure 10: CCT Tuning Range, $T_c=85^\circ\text{C}$

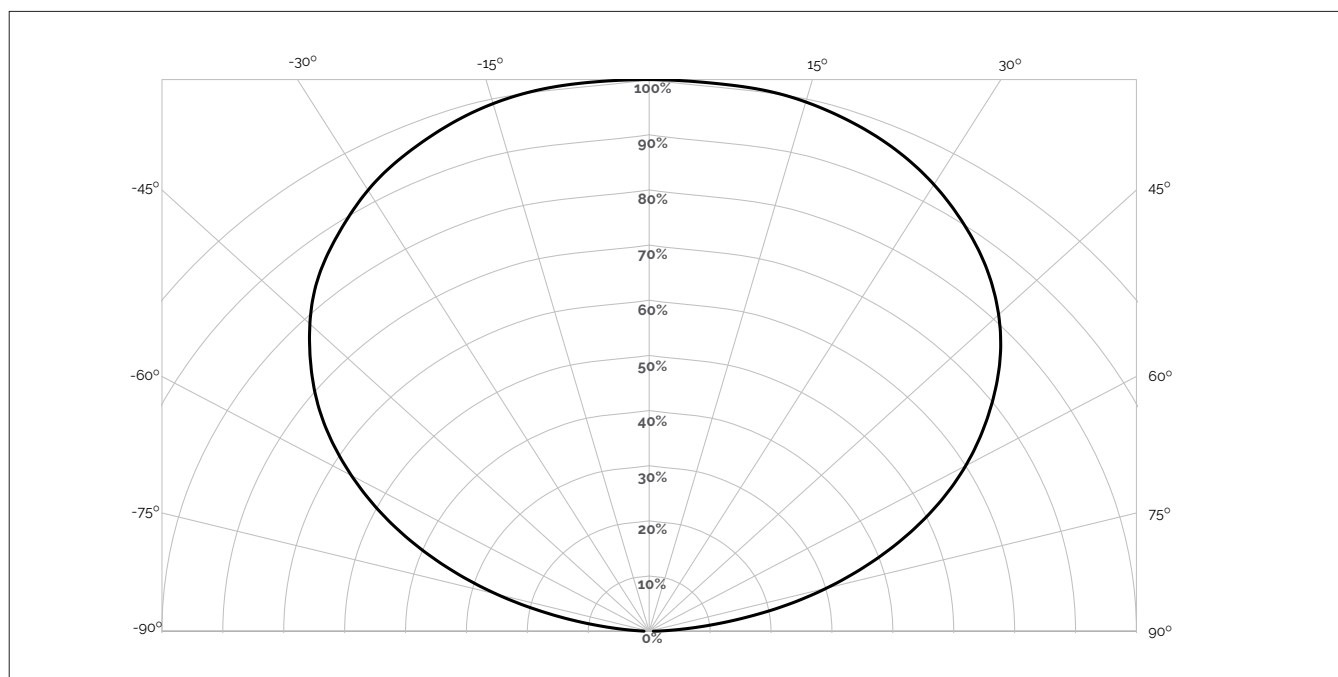
Figure 11: Typical Spatial Radiation Pattern

Figure 13: 2700K - 5000K with 90 CRI

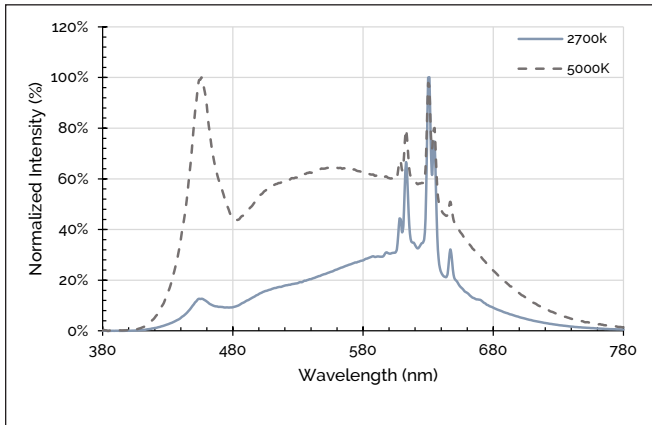
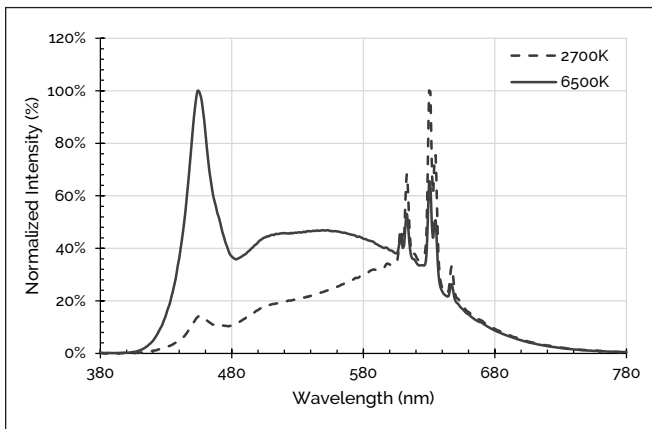


Figure 14: 2700K - 6500K with 90 CRI

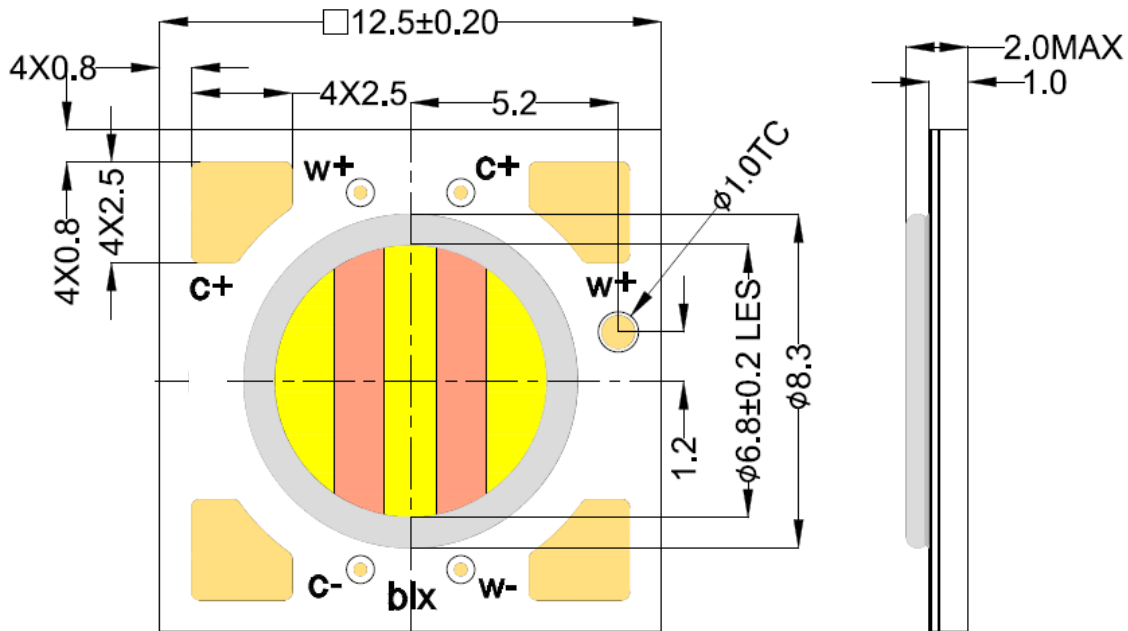

Figure 16: Graph of Bins in xy Color Space, Tc=85°C

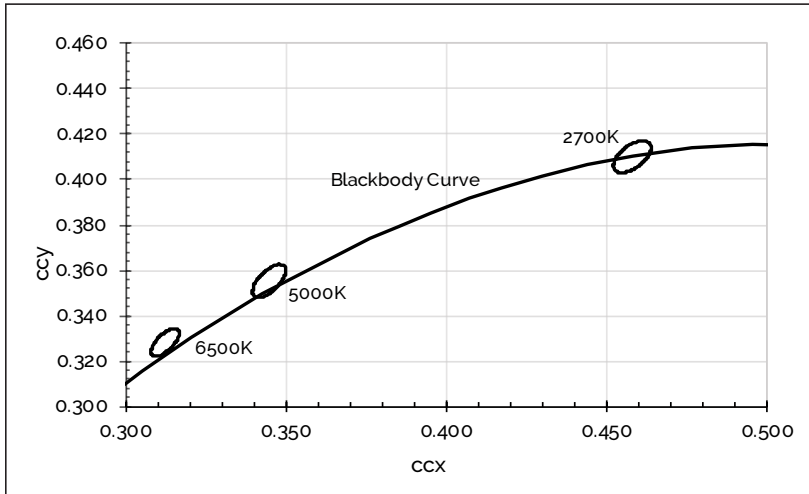


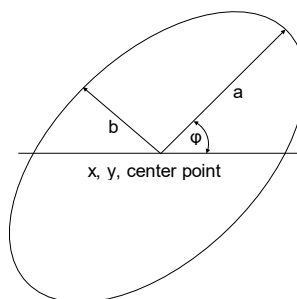

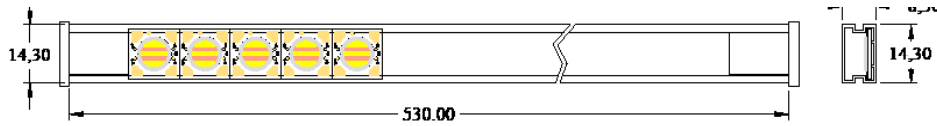

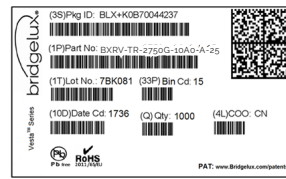

Notes for Figure 18:

1. Each tube holds 40 Vesta Series Tunable White 6mm arrays.
2. Four tubes are sealed in an anti-static bag. Up to five such bags are placed in a box and shipped. Depending on quantities ordered, a bigger shipping box, containing four boxes will be used to ship products.
3. Each bag and box is to be labeled as shown above.
4. Dimensions for each tube are 509.0 mm (L) x 18.4 mm (W) x 9.5 mm (H). Dimensions for the anti-static bag are 100.0 mm (W) x 625.0 mm (L) x 0.1 mm (T) and that of the inner box are 58.7 mm (L) x 13.3 mm (W) x 7.9 mm (H).

Vesta Series Tunable White arrays are classified as Risk Group 1 when operated at or below the maximum drive current. Please use appropriate precautions. It is important that employees working with LEDs are trained to use them safely.

CAUTION: RISK OF BURN

Do not touch the Vesta Series LED array during operation. Allow the array to cool for a sufficient period of time before handling. The Vesta Series LED array may reach elevated temperatures such that could burn skin when touched.

CAUTION

CONTACT WITH LIGHT EMITTING SURFACE (LES)

Avoid any contact with the LES. Do not touch the LES of the LED array or apply stress to the LES (yellow phosphor resin area). Contact may cause damage to the LED array.

Optics and reflectors must not be mounted in contact with the LES (yellow phosphor resin area). Optical devices may be mounted on the top surface of the Vesta Series LED array. Use the mechanical features of the LED array housing, edges and/or mounting holes to locate and secure optical devices as needed.

The product is sensitive to moisture. It is not recommended for use in outdoor application or damp environment.
